

## Why is it important for my child to have a legal father?

Establishing paternity may allow your child to receive many benefits, including legal, social, and psychological:

- child support
- Social Security
- disability insurance
- inheritance
- pensions
- medical information
- visitation rights
- sense of identity
- psychological bonds between father and child
- may have better emotional performance
- may have fewer behavior problems

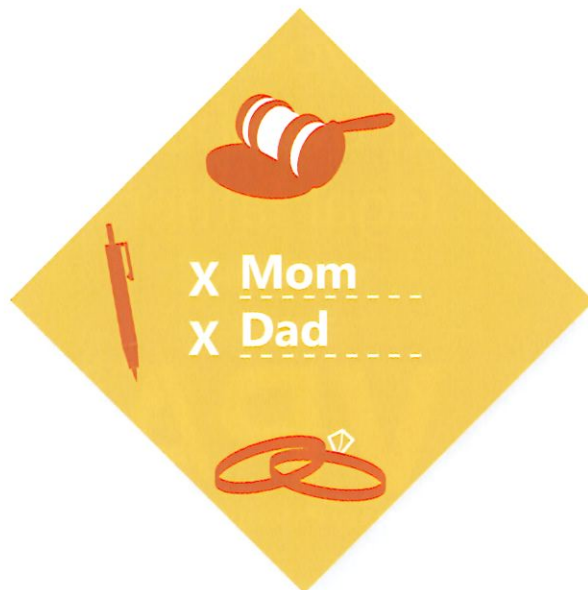
## Who can be listed on the birth certificate?

In addition to your child's mother, the legal father can be listed.

## How can I establish my child's legal father?

1. If a mother is married at some time during the pregnancy or at birth.
2. If a court enters an order naming the father.
3. If both parents fill out and sign the paternity affidavit form.

**One of these criteria must be met for your child's father to be on the birth certificate.**



## What is a paternity affidavit?

It's a free and easy legal document that both parents complete so their child can have a legal father.

**This is a FREE document!**

## Where can I get one?

The paternity affidavit can be completed anywhere, but it must be signed in the presence of a notary public.

## What do I need to complete the paternity affidavit?

**Both parents need to bring:**

**One current U.S. government-issued ID:**

- driver's license
- state photo ID
- United States passport/visa
- military ID
- permanent residence card
- employment authorization card
- current school photo ID

**— OR —**

**Two to three of the following:  
(names and current addresses must match)**

- income tax return
- court documents
- expired driver's license plus one other document in the same name
- criminal record
- hospital bill
- Medicaid/Medicare card
- rent or mortgage receipt
- car title
- insurance policy
- medical card
